| Are there services covered before you meet your deductible? | Yes. Office visits, <u>preventive care services</u> , <u>urgent care</u> , <u>rehabilitation services</u> , <u>habilitation services</u> , outpatient mental health, outpatient substance abuse, pediatric vision services, pediatric dental exam, and <u>prescription drug</u> benefits are covered before you meet your <u>deductible</u> . <u>Copayments</u> and <u>coinsurance</u> amounts don't count toward the <u>network deductible</u> . | This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. Does this plan provide Minimum Essential Coverage? Yes

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.

Does this plan meet the Minimum Value Standards? Yes
